There is a lot more to this topic than self-care, and there are different types of stress that we can be exposed to through the workdays. Join Mary Tatum for an informative non-emotionally invasive discussion about these types. You will learn about how our brains are hard-wired to help each other in stressful moments.

How not to help the defense attorney in child sexual abuse cases – Lawrence Jay Braunstein, JD, Braunstein & Zuckerman, Esqs.

This program, presented by a defense attorney (and former prosecutor), will acquaint law enforcement, prosecutors, medical practitioners, mental health practitioners, child protection caseworkers and victim assistance agency personnel with the intimate workings of the defense in child sexual abuse cases: the preparation of a defense case, investigative techniques, pretrial motion practice and discovery, examinations before trial, jury selection, defense trial strategy, demonstrative evidence, trial exhibits, cross examination techniques, and courtroom psychology.

By having a broad overview of both pretrial and trial procedures, and how the defense will approach its preparation during each phase of the litigation, the expert and lay (fact) witness will be better prepared in understanding its individual role in the proceedings, and better prepared to maximize its participation in the overall litigation.

Motivational Interviewing Overview – Barbara Orr, M.S., Orr Training Services, LLC

This workshop provides an overview of an evidence-based communication approach developed by William Miller and Stephen Rollnick which is significantly effective with resistant persons. Because we deal so often with people who don't seem to be in "change mode" and can experience accompanying frustrations and stand-stills due to this. Motivational Interviewing is a particularly useful approach to learn. It helps the helper avoid burn-out and discouragement; it assists the client in clarifying their own motivation to change.

Motivational Interviewing is broadly applicable. Essentially, it is a strategic communication style that helps individuals develop a commitment to change by facilitating their recognition of problem behavior and "building their own case for positive change". It recognizes the stage of change a client is in as a guide to the kind of questioning and responses a helper gives. Excellent listening skills, effective questioning, and clarifying reflections and summarizations are some of the key elements of this approach. As such, it's a decidedly nonadversarial, non-confrontational means of influencing clients to see discrepancies in what they present, to accept and resolve ambivalence they may have about change, and initiate change by tapping into their own intrinsic values and goals. It keeps helpers from arguing with clients - reducing burnout - and augments other skills and modalities.

Participants attending this workshop will learn the basic tenets of Motivational Interviewing, as well as have some time to practice the skills associated with the approach. They will also be encouraged to attend a more thorough M.I. workshop to allow more ample preparation to begin using the skills and concepts of this important approach in their everyday work.

How law enforcement can avoid getting handcuffed by the defense attorney and how to survive cross examination for forensic interviewers - Lawrence Jay Braunstein,

JD, Braunstein & Zuckerman, Esqs.

Testifying in court is usually not an endeavor which law enforcement officers look forward to. This class, presented by a defense attorney (and former prosecutor), will deal with issues and topics that arise during trial such as interrogation (alright, interview) techniques, Miranda, and one party consent telephone calls. What to say and how to say it during direct and cross examination will also be discussed.

Successful child sexual abuse prosecutions depend in large part on the quality of the forensic interview of the child, and the testimony of the forensic interviewer. This presentation will focus on the various protocols used during the interview process, disclosure as

a process or event, forensic linguistics, videotaping of forensic interviews, and how to best present your testimony in the courtroom both on direct examination and cross examination. The goal of the program is to "re-educate" forensic interviewers to understand and consider how what they do in the forensic interview room/CAC will "play out" in the courtroom.

Working Effectively with the Lesbian, Gay, Bisexual, and Transgender Youth - Liz Bradbury, Director of the Training Institute of the Bradbury-Sullivan LGBT Community Center

Learn how to work with the LGBT youth population and their families, and how to avoid creating barriers to communication because of inadvertent misuse of language or a lack of information about cultural context. This training will focus on language, cultural understanding, sensitivity, legal requirements and laws, LGBTQ minority stress, mitigating self harm, outreach, and leading best practices when working with the Lesbian, Gay, Bisexual, and Transgender Community.



Liz Bradbury, Director of the Training Institute of the Bradbury-Sullivan LGBT Community Center

Liz Bradbury has more than 40 years experience working as a professional advocate for the LGBTQ community and is recognized as a national expert on LGBTQ issues. She is currently the Director of the Training Institute of the Bradbury-Sullivan LGBT Community Center. Since she began as an LGBTQ advocate in the 1970s she has led 3 key LGBTQ civil rights organizations, produced an LGBTQ newspaper for 18 years, and has written over 400 published articles and columns on LGBTQ issues. She has helped to craft and pass key LGBT civil rights legislative bills in Pennsylvania state-wide, and in 12 Pennsylvania municipalities. Bradbury led the passage of the first municipal non-discrimination legislation in Pennsylvania to include "gender identity" as a protected class.

She has been called in as an expert on LGBTQ issues to government agencies and on radio and television. She served for 15 years on the Human Relations Commission of the City of Allentown (including three years as Chair) where she wrote the guidelines for discrimination investigations and trained investigators. She is a certified SAGE (The National Organization for Advocacy and Services for LGBT Elders) Trainer.

In 2018 she was appointed by Governor Wolf to the Pennsylvania Alzheimers State Plan Task Force. In the last 4 years, Bradbury has presented more than 150 uniquely tailored trainings to over 8500 people in widely diverse organizations and businesses, see a partial list above. In 2018, Bradbury presented an international webinar on LGBTQ health issues with the Pennsylvania Secretary of Health, Dr. Rachel Levine. She wrote the chapter 'Caregiving Concerns for Older LGBTQ Adults' in the groundbreaking new LGBT healthcare anthology "Bodies and Barriers - Queer Activists on Health." which was released in January, 2020.

Lawrence Jay Braunstein, JD, Braunstein & Zuckerman, Esgs.

Larry Braunstein is an attorney with over 30 years of experience. He is a Fellow of the American Academy of Matrimonial Lawyers and the International Academy of Matrimonial Lawyers, and, since 1985, has focused his practice in the areas of Matrimonial and Family Law and related civil and criminal litigation. He is also trained in Collaborative Family Law, and mediation. In addition, he has developed an expertise in the areas of child custody litigation, and litigation involving allegations of child sexual abuse, physical abuse and abusive head trauma (shaken baby). He is recognized by his peers as an expert in these areas, and is often hired by other lawyers to assist them in their litigation as a specialist in these areas.

Larry also regularly lectures as an invited speaker, both nationally and internationally, in the areas of child sexual abuse, physical abuse and abusive head trauma (shaken baby), child custody litigation, expert witness testimony, courtroom psychology, and trial procedures to judges, attorneys, medical and mental health professionals, law enforcement personnel, prosecutors, and child protection service personnel.

Since 2007, Larry has been named as one of the "Top Attorneys in the New York Metro Area" as published in the New York Times Magazine's Super Lawyer Section, and one of the top Twenty-Five "Super Lawyers" in the Westchester County, New York area. He is a member of the American Professional Society on the Abuse of Children (APSAC) and the Expert Faculty of the International Society for Prevention of Child Abuse and Neglect (ISPCAN).

Since 1999, Larry has been a member of the faculty of the New York City Police Department Sex Crimes and Child Abuse Investigation Course. In 2004, he was the only defense attorney invited by the FBI to participate as a member of the working group to plan the International Online Child Sexual Victimization Symposium, and to present to both the working group and the Symposium. In 2008,

he provided training for the FBI Behavioral Analysis (Profiling) Units. In 2009, Larry was appointed to serve as a legal advisor to the DSM-V Revision Task Force, Sexual Disorders Group, of the American Psychiatric Association.

Kelly Hagenbaugh, Community Counseling Coordinator, Network of Victim Assistance (NOVA)

Kelly Hagenbaugh is a Licensed Social Worker who has had over 14 year's experience working in the field of trauma. Kelly received her Masters Degree in Social Work from the University of Buffalo while working with children and their families through community outpatient care. Kelly continued to work with children in families in a Treatment Foster Care and Adoption program in Virginia for over 7 years which included working with community partners to develop the best possible care for vulnerable children and their families. At that time Kelly also began training and developing programs to best serve the community. Currently, Kelly is the Community Counseling Coordinator at Network of Victim Assistance (NOVA). Kelly came to NOVA to help develop trauma counseling in the community for victims of crime. Kelly is certified in Trauma-Focused Cognitive Behavioral Therapy (TF-CBT); Problematic Sexual Behavior Cognitive Behavioral Therapy (PSB-CBT) as well as trained in Eye Movement De-sensitization and Reprocessing (EMDR). Kelly supervises counseling done in the community as well as the Restoring Families Program that works with children and youth who sexually act out. Kelly is also a certified yoga instructor and has helped to bring Trauma Informed Yoga to NOVA clients.

Barbara Orr, M.S., Orr Training Services, LLC

Barbara Orr has over thirty-seven years of experience working as an inpatient counselor, juvenile probation officer, adolescent and family therapist, and supervisor of juvenile justice programs. She holds a B.S. in Sociology from Shippensburg University and a M.S. in Clinical Psychology from Millersville University, and received training at the Philadelphia Child Guidance Clinic in family systems work. She served as adjunct professor in the Psychology Department at Millersville University. She currently trains and consults full-time with agencies, facilities, and organizations that provide services to children, adolescents and families, as well as to private businesses.

Missy Page, York County Coordinator, Safe and Healthy Communities Initiative

Missy attended Millersville University majoring in Elementary and Special Education. She has devoted that the past 25 years working in non-profit, specifically with victim-serving organizations. She worked as the Community Prevention Educator and Finance Manager at Victim Assistance Center (VAC) for nine years where she received a wealth of grant management experience as well as community outreach experience. In her time at VAC, she grew the prevention program significantly from serving roughly just 3,500 students per year to serving over 10,000 per year. Additionally, she was a client advocate/grant manager for a domestic violence organization assisting victims of domestic violence with writing Protection From Abuse orders along with helping them to access resources in the community.

Mary Tatum, Director, Child Advocacy Center of Clearfield County

Mary Tatum is the Director of the Child Advocacy Center of Clearfield County (CAC-CC). Graduating from Penn State in 2006 with her Bachelor of Science in Human Development and Family Studies she knew she wanted to help her local county. Before becoming the director of the CAC-CC, she obtained extensive experience working in the human services field for over 11 years. Ms. Tatum has worked with youth in Clearfield County as a Site Coordinator for Project S.U.C.C.E.S.S. and Project S.O.A.R. Ms. Tatum has a keen understanding of mental and behavioral health and the importance of supporting families as they heal from various traumas. Tatum has years of experience providing adoption and permanency services to adjudicated children and youth throughout the Commonwealth. She believes in treatment for both the child victims of abuse and their non-offending caregivers.

During her time working in the social services field, she realized that she wanted to further her education. In 2011 she obtained her Master of Public Administration from Capella University. Mary came to the CAC-CC with years of supervisory and administrative background. Supervising and coordinating with multiple individuals over the past 11 years she has an exceptional ability to act as the Coordinator for Clearfield County's Multidisciplinary Investigative Team (MDIT). She is currently working on her Doctorate of Public Administration through Capella University with an anticipated graduation year of 2021. Tatum is looking forward to continuing to provide support to children and families of Clearfield County.

She enjoys speaking to communities and schools about a variety of topics including understanding the signs and symptoms of child abuse, trauma and resiliency, victim service agencies and the benefits provided to the community, and careers within the investigative
